SUBJECT: RENEWAL OF ENVIRONMENTAL MANAGEMNT PLAN.

This is with the reference to your letter No.Nill dated 10th January 2020 on the subject noted above. The Sindh Environmental Protection Agency has reviewed and extended your approval for the period of one year for strict implementation on same terms and conditions as mentioned in approval vide letter no. SEPA/ROK/GF-510/66/19 for your facility situated at plot #C-30, Sector 16-B, North Karachi Industrial Area, Karachi with addition to compliance of following conditions.

1. That mitigation measures provided in the EMP report shall strictly be implemented and followed by the management in order to minimize or reduce the impacts of the activities on physical and biological environment
2. That industry shall strictly comply with Sindh Environmental Quality Standards (SEQS) and Sindh Environmental Protection Act, 2014.
3. That no violation of any Rules, Regulations and Provisions of Sindh Environmental Protection Act, 2014 shall be made.
4. That gaseous emissions released from all industrial process shall conform/meet to the Sindh Environmental Quality Standards (SEQS) all the time, at no time the discharge/emission levels shall go higher than stipulated standards of Sindh Environmental Protection Agency.
5. That waste water generated during the industrial process will be treated and must conform/meet to the Sindh Environmental Quality Standards (SEQS) all the time, at no

time, the discharge levels shall go higher than stipulated standards of Sindh Environmental Protection Agency.

- 6 That management shall submit the environmental monitoring reports with respect to air, water and noise as prescribed in SMART RULES, 2014. In case, of not submitting the reports during the three consecutive months w.e.f. the date of renewal of approval, then this approval shall stand cancelled without any prior notice from this office.
- 7 That this approval is provisional and shall be treated canceled without any intimation if any of the above mentioned conditions or conditions mentioned in original approval are being violated or not complied with.
- 8 That if any type of fact /information being concealed by Proponent or Consultant then they (Proponent or Consultant) will be responsible and action will be initiated as per law.
- 9 That this approval is not valid for extraction of ground water.
- 10 This is issued with the approval of competent authority i.e. (DG EPA Sindh)
- 11 This approval is valid up to year **11-06-2021**.
